Eden Theological Seminary is called to strengthen the life of the church by educating women and men for ministry, enlivening critical reflection on faith, and supporting bold Christian discipleship.

Eden Theological Seminary was established in 1850 to educate leaders of immigrant Evangelical congregations for North American religious life. Connected to the subsequent United Church of Christ (UCC), Eden has actively pursued national and global ecumenical collaborations and the progressive Christian movement. Eden offers a variety of accredited degree and non-degree programs focused on providing diverse perspectives, hands-on experience, and leadership skills.

The Christian Church (Disciples of Christ)'s (DOC)racial justice ministry historically supported training for volunteer groups of leaders in regions to supply anti-racism training. It has been difficult to maintain a core group of leaders and some regions never developed a training ministry. Currently, the UCC and DOC and other denominations require anti-racism training for clergy to maintain ministerial standing, creating more demand.

Realizing that training is not sufficient, leaders in the DOC and at Eden discussed how infrastructure that provides basic anti-racism training might also move people to act and live for racial justice in their communities. April Johnson, Executive Director of the DOC Reconciliation Ministry, called this the "Organizing School," a place where faith leaders learn the basics of organizing rooted in faith to change ourselves and our communities. In 2020 Dietra Wise Baker joined the Eden faculty as the Assistant Professor of Community Engagement and Contextual Education and gained institutional support to bring such a program into being as a non-degree program of the seminary. Dietra approached Traci Blackmon as Associate General Minister of the UCC's national Justice and Local Church Ministries. A collaboration began that will include the support of the DOC and UCC racial justice ministries for this Center for Lived Faith and Organizing at Eden.

The Hartford Institute observes there are approximately 350,000 religious congregations in the U.S. representing approximately 63 million people who attend some religious institution weekly. Sadly, Sunday morning continues to be the most segregated time in America. But there are signs that a major change is underway. Multiracial congregations have nearly doubled in the past decade to 13.7 percent.

Simultaneously, people of color (POC) and other marginalized identities have born traumas - historical and contemporary, repetitive, and collective — well before recent surges of racialized violence. Even within the movement space, trauma seems unrelenting and social divides have widened. A comprehensive healing-centered organizing strategy is needed to prevent the further deepening of socio-political chasms in this country and should be embedded in a broader community response to trauma.

The Center for Lived Faith and Organizing seeks to equip leaders and their faith communities for effective participation in long haul racial justice work. The Center will be part of the non-degree offerings at Eden Seminary. It will provide entry-level offerings that biblically and theologically ground faith leaders in community work. The offerings will enable these faith leaders to connect with each other and for their congregations to connect to networks of organizing in their own contexts. It will not replace or duplicate those organizing networks.

This institutional location is cost-effective by utilizing already-existing infrastructure and practices for curriculum and assessment, instructors and student engagement. As a seminary with existing participation by both UCC and DOC constituents and those of multiple other denominations, it provides a common space for connecting. Churches already look to the seminary as the part of the church ecology that engages in leadership equipping and formation.

Vision Statement: A replicable program that yields thousands of faith communities who embody a common understanding, language, and practice of justice. It includes people of faith engaged deeply in transforming the world through community and cultural organizing grounded in theology and faith.

#### Objectives:

Long-term strategy to address the needs of faith based social justice advocates. The Center for Lived Faith and Organizing will educate, train and connect leaders with local and regional partners for a long and sustainable ministry in organizing and justice work.

- 1. Dismantle racism. Racial justice theologies will catalyze the program. The Center will educate and train people, white and BIPOC, on the different healing journeys necessary to confront internalized racism and systemic violence in the world

#### YOUR PROJECT IMPLEMENTATION PLAN (200 words or less)

The program will launch in January 2023 with a national event also available for Eden students as part of a one-credit-hour degree credit. During the spring of 2023, the Center will offer 5 courses available for continuing education credits or toward a recognized non-degree certificate. Three additional courses will be added in the spring of 2024. Instructors identified and contracted with Eden Seminary through the Center will teach these courses. The program anticipates a registration of 100 participants in year one, increasing to 500 participants by year five.

Tentative courses: State of the Movement and Faith: Since Ferguson and Charlottesville, Faith Organizing and Theories of Social Change, Tools for Organizing Congregations, The Gospel and the Abolitionist Framework, Reproductive Justice and Strategies for Organizing. Mutual Aid Communities of Care and the Gospel, Organizing for Decarceral Liberation: Mass Incarceration, Supervision, Immigration and Police

The Center also will directly connect with local churches, particularly in the UCC and DOC. The director, instructors, and participants will offer workshops and support to local social justice teams ready to organize. 250 such visits are anticipated during the first 5 years. The Center will offer "organizing assessments" to support local justice action and organizing engagement of UCC and DOC faith communities. During the first 5 years, 1000 of these assessments are anticipated.

#### PROJECT EVALUATION (200 words or less)

This project aims toward the goal of a theological and biblically grounded movement for justice in the UCC and DOC denominations. It aims toward strategic and strengthened relationships between the church and movement organizations across the country, thus adding to the power base of organizing networks. The anticipated outcome is 1000 UCC and DOC churches locally engaged in justice organizing in their communities as an act of Christian discipleship. Evaluation of this project will include both assessment of the Center's courses and educational design and of the outcomes of engagement of local faith communities with organizing networks. Course assessment processes for participants currently in place for Eden's degree courses will be utilized also for non-degree courses. These assessments are based on Eden's curricular goals and infused leadership capacities. The Seminary's registrar and director of assessment will coordinate this process with the director of the Center for Lived Faith and Organizing. The Center's director also will organize an annual evaluation of the program design and impact on congregations and organizing networks in consultation with project contributors. This will be assessed quantitatively related to numbers of participants and engaged congregations as well as qualitatively related to metrics from social change theory.

The project anticipates continued conversation with the UCC and DOC and other denominations for consideration of this Center as part of budgeted and on-going racial justice and community organizing ministries.







Dear Applicant:

Based on information supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from Federal income tax under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3).

We have further determined that you are not a private foundation within the meaning of section 509(a) of the Code, because you are an organization described in sections 509(a)(1) and 170(b)(1)(A)(ii).

Since you are not a private foundation, you are not subject to the excise taxes under Chapter 42 of the Code. However, you are not automatically exemple from other Federal excise taxes. If you have any questions about excise, employment, or other Federal taxes, please let us know.

Grantors and contributors may rely on this determination unless the Internal Revenue Service publishes notice to the contrary. However, if you lose your section 509(a)(1) status, a grantor or contributor may not rely on this determination if he or she was in part responsible for, or was aware of, the act or failure to act, or the substantial or material change on the part of the organization that resulted in your loss of such status, or if he or she acquired knowledge that the Internal Revenue Service had given notice that you would no longer be classified as a section 509(a)(1) organization.

Donors may deduct contributions to you as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to you or for your use are deductible for Federal estate and gift tax purposes if they meet the applicable provisions of Code sections 2055, 2106, and 2522.

Contribution deductions are allowable to donors only to the extent that their contributions are gifts, with no consideration received. Ticket purchases and similar payments in conjunction with fundraising events may not necessarily qualify as deductible contributions, depending on the circumstances. See Revenue Ruling 67-246, published in Cumulative Bulletin 1947-2, on page 104, which sets forth guidelines regarding the deductibility, as charitable contributions, of payments made by taxpayers for admission to or other participation in fundraising activities for charity.

In the heading of this letter we have indicated whether you must file Form 990, Return of Organization Exempt From Income Tax. If Yes is indicated, you are required to file Form 990 only if your gross receipts each year are normally more than \$25,000. However, if you receive a Form 990 package in the mail, please file the return even if you do not exceed the gross receipts test. If you are not required to file, simply attach the label provided, check the box in the heading to indicate that your annual gross receipts are normally \$25,000 or less, and sign the return.

If a return is required, it must be filed by the 15th day of the fifth month after the end of your annual accounting period. A penalty of \$10 a day is charged when a return is filed late, unless there is reasonable cause for the delay. However, the maximum penalty charged cannot exceed \$5,000 or 5 percent of your gross receipts for the year, whichever is less. This penalty may also be charged if a return is not complete, so please be sure your return is complete before you file it.

You are not required to file Federal income tax returns unless you are subject to the tax on unrelated business income under section 511 of the Code. If you are subject to this tax, you must file an income tax return on Form 990-T, Exempt Organization Business Income Tax Return. In this letter we are not determining whether any of your present or proposed activities are unrelated trade or business as defined in section 513 of the Code.

You need an employer identification number even if you have no employees. If an employer identification number was not entered on your application, a number will be assigned to you and you will be advised of it. Please use that number on all returns you file and in all correspondence with the Internal Revenue Service.

Revenue Procedure 75-50, published in Cumulative Bulletin 1975-2 on page 597, sets forth guidelines and recordkeeping requirements for determining whether private schools have racially nondiscriminatory policies as to students. You must comply with this revenue procedure to maintain your tax-exempt status.
